Information we collect

Glamour Make-up processes your personal data because you make use of our services or because you have provided data during communication with Glamour Make-up.

Below you can find an overview of the information that we store:

- First and surname
- Gender
- Address details
- Telephone numbers
- E-mail addresses
- Other information that you have provided actively in correspondence or via telephone or email
- Course registrations and payment details
- Course attendance
- Nationality
- Education
- Mother tongue
- Language skills

Objectives of storing personal data

Glamour Make-up processes your personal details for the following objectives:

- To be able to call, e-mail or contact you by mail if this is required to provide our service
- To be able to inform you about changes in our services and products
- To be able to deliver our services (e.g. in-house language training) at your location
- The handling of your payment
- Sending of a Newsletter (in each Newsletter you can unsubscribe yourself in a simple way)
- Glamour Make-up also processes details if we are legally obliged to do so, for instance for Bookkeeping and for the Tax Office.

Automated decision making

Glamour Make-up does not make any decisions based on automated processes that could have (considerable) consequences for people. We refer here to decisions that are taken by computer systems or programs without any interference of humans.

How long will we store data?

Glamour Make-up does not store personal data any longer than is required for the objectives they were stored for initially.

Sharing of data with third parties

Glamour Make-up does not sell your data and provides these data only if required in the interest of execution of our services or in order to oblige with legal requirements. We have an agreement with the companies who process your data for us to guarantee the same level of security and confidentiality. Glamour Make-up remains responsible for these processes.

Cookies, or similar techniques we use

Glamour Make-up only uses analytical cookies that do not interfere with your privacy. A cookie is a small text file that will be stored on your computer, tablet or smartphone when you first visit our website. The cookies that are used by us are necessary for the technical operation and optimisation of our website. You can discard the cookies by changing the settings of your Internet browser in such a way that it will not store cookies. On top of that you can also remove all earlier stored information by changing the settings of your browser.

Checking, adapting or removing details

- You are entitled to view your personal data, to correct or to remove them. You also have
 the right to withdraw earlier given permission to process your personal data and to
 object to the processing of your data by Glamour Make-up. You also have the right to
 data transfer which means that you can file a request to send your personal details
 stored to yourself or to an organisation that has been authorised by you.
- You can send a request for insight, correction, removal, transfer of your personal details
 or you can request to withdraw your permission by sending an email to our Data
 Protection officer. You can also send your objection or contest the use of your personal
 details.
- In order to be sure that this request has been made by you, we ask you to make a copy
 of your identitiy card and attach it to the email. Blackout the photo, the MRZ (machine
 readable zone, the part with the numbers underneath the photo), passport number and
 Burgerservicenummer (BSN) This to protect your privacy. We will respond to your
 request as soon as possible.

How we protect your details

Glamour Make-up treats the protection of your data very seriously and will take appropriate action to avoid abuse, loss, unauthorised access, unwanted publication and unpermitted changes. Glamour Make-up has taken action to secure your personal details through:

- Use of protection software including virus scanners and firewalls.
